### HSVC 103-Introduction to Human Services Final Paper and Presentation The Current Issues in the Field of Human Services

**Assignment Objective:** To investigate a current issue of interest impacting the field of human services.

### **Course Learning Objectives**

- gain a solid foundational understanding of the profession of Human Services to include the diverse settings, populations, and interventions available to the human services practitioner.
- identify social, economic, political and cultural factors within American society, which influence how human service problems are identified and how services and fields of practice are created to address these problems.

**Assignment Instructions:** As we begin to explore the field of human services, this assignment is designed for each one of you to focus on one current issue/trend/aspect in human services that you find interesting. This paper and presentation will reflect a review and research of evidence-based resource materials. You will research, select, read, and evaluate through the process of reflection, a minimum of three articles. These articles will come from a variety of sources to include newspapers, academic journals, news magazines such as *Time* or *Newsweek*, or web news sources such as *The New York Times*. Papers should include the following components:

- A title page in APA format (example provided)
- An introduction and brief summary of the issue including why you selected this issue/topic (one to two paragraphs)
- Statement of thesis-What idea or perspective do you want your paper to support? (one paragraph)
- Examples/details/explanations from your articles to support your thesis (one to two pages)
- Conclusion (one to two paragraphs)
- Reference Page written in APA format

#### **Important Tasks and Dates to Remember**


- 1. Review assignment and ask any questions you have.
